PRI reporting is the largest global reporting project on responsible investment. It was developed with investors, for investors.

PRI signatories are required to report publicly on their responsible investment activities each year. In turn, they receive a number of outputs, including a public and private Transparency Report.

The public Transparency Reports, which are produced using signatories' reported information, provide accountability and support signatories to have internal discussions about their practices and to discuss these with their clients, beneficiaries, and other stakeholders.

This public Transparency Report is an export of the signatory's responses to the PRI Reporting Framework during the 2023 reporting period. It includes the signatory's responses to core indicators, as well as responses to plus indicators that the signatory has agreed to make public.

In response to signatory feedback, the PRI has not summarised signatories' responses – the information in this document is presented exactly as it was reported.

For each of the indicators in this document, all options selected by the signatory are presented, including links and qualitative responses. In some indicators, all applicable options are included for additional context.

Ardian's approach as a responsible investor is rooted in our corporate purpose: to invest all of ourselves in building companies that last. Committing to sustainability is central to how we carry out our fiduciary duty to build a resilient portfolio that creates value for our clients. Across our investments, we ensure that the companies, assets and GPs we invest in have future-proofed business models that enable them to achieve long-term success. Through sustainability, we manage risk and create value by working collaboratively with all our stakeholders to meet their expectations and make progress together.

This people-centric approach has been the foundation of how we do business, build trust, and drive performance in our ecosystem. Sustainability has been central to Ardian's investment practices for 15 years. We were one of the first in the industry to take a leadership position in this area and were an early signatory of the UNPRI, in 2009. In the past 15 years, our success has been built on a bottom-up strategy tailored to the specificities of our different investment strategies but grounded in robust common standards.

Central to how we have met our goals and continue to develop our approach is our investment in specialist sustainability expertise. Our Sustainability team has grown to include 14 ESG professionals, led by Ardian's Head of Sustainability, Candice Brenet. They are responsible for developing and implementing Ardian's Sustainability strategy across the firm and the investment portfolio and have an extensive experience and technical skills, on climate change, data management, ESG regulations, etc. In order to cement sustainability as a driver of our strategy and governance, our Head of Sustainability is a member of the Operational Executive Committee and our Sustainability Committee is comprised of 11 senior members of Ardian, including 3 Executive Committee members.

Our Sustainability program is built around three priorities: building a fairer society, contributing to the climate transition and driving measurable impact.

Fairer society

We are committed to promoting fairer social outcomes and creating equal opportunities by making Ardian and the companies we invest in more inclusive, diverse and equitable.



On the initiative of Ardian's top management, we are willing to act for a better social balance and enhance equal opportunities: the work achieved by the Sustainability team, by the Human Resources, by the Ardian Foundation all contribute – jointly – to that. Our sustainability approach has a very strong human-centric component that was initiated by our commitment to value sharing in 2008, when we pioneered the practice of sharing some of the capital gains we achieve on exit, with the employees of those companies. Since then, Ardian has redistributed a portion of its capital gains to more than 31,000 employees from 43 exited portfolio companies.

Climate transition

Climate transition has been a priority for Ardian since 2015 when we co-founded the Initiative Climat International alongside four other French GPs.

To scale our impact, we have invested significantly in the transition, through a sizeable renewable platform. As of 2022, Ardian has invested €1.9bn in renewables across all infrastructure fund generations. Moreover, Ardian has partnered with FiveT Hydrogen to create a joint venture, Hy24, entirely dedicated to clean hydrogen. We also protect and drive long-term value by helping our portfolio companies manage climate-related risks, deploy energy-efficient solutions and implement transition plans that build resilience. We provide technical support to our majority-owned portfolio companies to help them measure their carbon footprint and have started assessing the carbon footprint of our minority-owned portfolio companies.

Finally, we are supporting our portfolio GPs to manage climate risk by engaging proactively with them to share best practices.

3. Mesurable impact

Making concrete and measurable improvements in our portfolio companies' and GPs' sustainability performance is an important value creation lever. Through our data management system, which covers 98% of our AUM, we collect and analyze large volumes of sustainability data, allowing us to closely monitor the sustainability performance of our portfolio. We assess our majority-owned companies' performance against our sustainability measurement methodology, developed in 2019, in line with the UN SDGs. This methodology enables us to examine companies' positive and negative contribution along their entire value chain and implement ESG roadmaps. We agree on targets with companies and monitor their progress on an annual basis. Since 2009, we have supported 190 portfolio companies through our Sustainability Engagement Program and monitored the performance of almost 300 GPs since 2011. In 2022, we have included our Private Credit and Co-Investment strategies into the data collection process.

Sustainability has been at the heart of Ardian's investment philosophy for 15 years, and as such, we take action to deliver against our three priority pillars, both internally, and with portfolio companies and GPs we invest in.

1. Fairer society

Over the past decade, Ardian's commitment to value sharing has anchored our ambition to contribute to a fairer society and has been extended both internally and in our approach as an investor. In 2022, we became the first European company to join Ownership Works, a US non-profit organization that partners with companies and investors to provide employees with the opportunity to build wealth at work.

Its mission aligns with our ambition to see value-sharing mechanisms in our portfolio companies become accessible for everyone. In our portfolios, at the end of 2022, 65% of our Buyout, Expansion and Infrastructure portfolio companies had profit-sharing schemes in place and 29% had employee shareholding schemes in place. We have also increased employee share ownership within Ardian – which now stands at c.50% – and introduced a value sharing scheme covering all employees. Internally, through our focus on diversity and inclusion, we increased the proportion of women in our investment teams to 24% and have set a target to reach 40% by 2030.

2. Climate transition

One of the most impactful ways that we can accelerate the transition is through our investments.



In the past year, we launched two funds dedicated to renewable investments: our hydrogen joint venture, Hy24, and Ardian Clean Energy Evergreen Fund, our first open-ended vehicle dedicated to financing the energy transition. We are also taking advantage of the wider opportunities associated with the transition through our core infrastructure funds: for example, in 2022 we acquired Green Yellow, a company which installs energy efficiency schemes. We have also developed proprietary databases and analytical tools that support our investment offering. Ardian Air Carbon, which models emissions from our airports, and Opta, which maximizes the efficiency of our wind farms, continue to help us reduce operational emissions. This year, we significantly reinforced our internal resources and added specific expertise to our Sustainability team, which now includes a climate expert, an agro-engineer and specialists in biodiversity and data.

At a higher level, we have extended our collaboration with the One Planet Sovereign Wealth Fund initiative (OPSWF) of which Ardian is a founding member. Since 2022, we are leading a working group of investors and asset managers on green hydrogen initiatives to build concrete investable solutions at scale.

Mesurable impact

In our Secondaries & Primaries portfolio, we founded our Annual GP Monitoring Program in 2011 to engage on sustainability with our portfolio GPs. It has allowed us to monitor the sustainability performance of these GPs and give individual feedback to help them benchmark their progress at the corporate and portfolio levels and improve their practices.

As our investment has grown, the program has accelerated – in 2022, we held around 40 individualized feedback sessions with GPs as part of our work to influence and enhance their approach to sustainability. As a result of our engagement, 90% of GPs whose funds we invest in monitor ESG during the ownership period, and 93% have a formal responsible investment policy in place (compared to less than 10 GPs a decade ago). We see this continued engagement as central to helping drive further progress across the industry. In 2022, in addition to the long-standing Ardian Sustainability Engagement Program and as a further way of supporting our portfolio companies in their sustainability journey, we have continued to develop Ardian Circle in 2022. Ardian Circle is a community and program of workshops that brings together executives from our portfolio companies to find concrete solutions to the social and environmental challenges that they face.

We held six Ardian Circle workshops in 2022, covering topics including diversity and inclusion, disability, ESG regulations, carbon footprint assessment and energy efficiency. These workshops brought together 142 participants from 42 portfolio companies. We have been implementing new processes and practices to support the implementation of the EU Sustainable Finance Disclosure Regulation (SFDR) while maintaining our long-term responsible investment approach. Indeed, we have always focused on quality assets and worked towards maximizing resilience and sustainable performance. As a result, as of the end of 2022, more than 75% of funds raised since the implementation of SFDR are classified as Article 8 or 9. Finally, to further reinforce our capacity to implement the evolving ESG regulation requirements, we have established a Sustainability Compliance joint venture with two regulatory experts and an Impact Committee involved during due diligence process for Sustainable Investments in the meaning of SFDR.

Section 3. Next steps

As we look ahead, we will continue to build on our strong foundations in responsible investment to enhance sustainable value creation in the years to come. Our people-centric approach will continue to help us align interests with our stakeholders. Through dialogue with our portfolio companies and GPs, investors, employees, and peers, we will ensure sustainability continues to drive long term value creation across the Ardian ecosystem. Indeed, as a responsible investor, we aim at joining forces within the private investment industry to drive progress on the sustainability agenda across geographies. As such, we will remain actively involved in strategic coalitions on sustainability topics.



Ardian will continue to drive sustainable transformation and resilience in our portfolios and will also maintain our focus on financing the social and environmental transition as well as innovations for the future. To communicate meaningful ESG information and bring value to our stakeholders, we will continue to develop our different reporting channels.

Our approach to sustainability will remain pragmatic, prioritizing measurable progress to demonstrate value creation across our three thematic priorities, with commitments to:

Fairer society

- Continue action to create a fairer society, promote diversity and inclusion, and develop solutions supporting equal opportunities at Ardian and in our portfolios.
- Further develop our pioneering commitment on value sharing in our portfolios, especially around our new collaboration with Ownership Works.

Climate transition

- Finalize our climate strategy, covering both the corporate and the investment levels.
- Complete the Ardian Climate Tour, our global upskilling program to train all Ardian employees on the causes and consequences of climate change

Measurable impact

- Continue to drive concrete sustainability performance through continuous engagement with our portfolio assets and GPs, improved ESG data quality and analysis and continued measurement of progress
- Broaden knowledge sharing and influence within our portfolio assets, GPs and own employees, especially through our growing Ardian Circle community and future resource platform.

Engaging with portfolio assets and monitoring their Sustainability practices is instrumental in Ardian's approach.

Since 2009, Ardian has developed a robust ESG Engagement Program with its portfolio assets. Throughout the holding period, the Sustainability team provides support to the portfolio assets and actively monitors Sustainability performance. Ardian's Sustainability team conducts annual sustainability reviews of portfolio assets. Based on the reviews, tailored roadmaps and recommendations are designed for portfolio assets to improve their performance. The management of the climate risk is embedded in the investment and holding period processes. Ardian seeks to integrate consideration of climate-related risks and opportunities throughout investment strategies, with a tailored approach taking into account access to information. levers for improvement

and role in the transaction. When carbon is identified as material, climate-related topics are integrated in the due diligence phase. Investment teams with deal kits have a tool to screen, during due diligence, potential climate risks related to the investment opportunity.

Throughout the holding period, Ardian collects climate-related KPIs such as companies' Scope 1, 2, and 3 GHG emissions. For companies within scope of annual Sustainability Engagement Campaigns, and where carbon is material, Ardian supports companies' efforts to measure their emissions and mitigate their exposure to climate risks, including through emissions reduction. Agreed actions may be included in portfolio companies' action plan, which are developed with the company's management team. Ardian's coverage in respect of carbon footprint assessments for portfolio companies in which it maintains a controlling interest is >80%.

For the Infrastructure and Real Estate strategies specifically, Ardian, with the support of external consultants, also seeks to perform a climate trajectory analysis to determine potential gaps between levels of greenhouse gas emissions and alignment with the Paris Agreement forms as part of annual Sustainability engagement campaigns.

The trajectory analysis is based on the SBTi for Infrastructure and Carbon Risk Real Estate Monitor (CRREM) for Real Estate. While Ardian seeks to maximise the coverage of its assets subject to the Sustainability Engagement Campaign and climate trajectory analysis, there are occasions where portfolio companies or assets are excluded.

For Secondaries and Primaries, Ardian monitors GPs' climate practices at both the management company and investment levels through its annual ESG monitoring questionnaire and provides feedback and recommendations to improve when material. Information regarding our climate mitigation efforts is consolidated and communicated to Investors on an annual basis through our fund management reports.

ESG due diligence includes a climate component - covering aspects such as market risk, exposure to climate-related regulation or physical climate risk (indicative) to inform the investment decision.

For Secondaries and Primaries activities, partner GPs climate maturity is covered as part of the due diligence.

When material climate risks are identified, corrective action plan are implemented and monitored throughout the holding period In addition, climate related opportunities also informed the strategy of the firms with the creation of investment solutions that directly support the low carbon transition such as renewable/low carbon energy funds or funds to finance the refurbishment of the EU building stock.

Pre-due diligence

(A) Selection

The Investment team conducts preliminary screening to avoid investment in sectors which are explicitly listed as being banned by Ardian's investment restriction list and the Fund documentation.

Due diligence

The Investment team performs an ESG analysis of GPs to identify potential ESG issues relating to the opportunity and make sure that their activity is in line with our interests.

For primary investments, Ardian can seek to negotiate clauses in side letters barring investments in sectors banned by Ardian's Responsible Investment Policy whenever it is deemed necessary. These side letters request that underlying fund manager acknowledges Ardian's commitment to the UNPRI as well as Ardian's Responsible Investment Policy and applicable investment restrictions. To assess the potential performance of a primary fund manager, the investment team has developed a scoring matrix tool, composed of various parameters, including a dedicated section on sustainability and compliance with ESG principles. The ESG score is based on an internally developed ESG monitoring questionnaire which is submitted to GPs. The matrix is filled in for all the new primary investments and is updated during the holding period. This analysis results in a rating, representing 10% of the overall score which is included in the pro/cons summary of the GPs.

For secondary transactions, the portfolio undergoes a transparency analysis to identify any exposure to sectors that would be banned by Ardian's Responsible Investment Policy or the fund documentation. Afterwards, the investment team evaluates the underlying GPs ESG commitments using Ardian's proprietary scorecards when available, or public commitments taken by the GP.

Ardian strives to primarily invest in funds managed by GPs with a solid reputation and highest professional standards, which are often already concerned with ESG and thus more inclined to actively integrate ESG considerations in their own investment practices.



Investment decision

(B) Appointment The investment memos always have a dedicated ESG section which includes a summary of the analysis undertaken during due diligence. The investment memos are then submitted to the Investment Committee who is ultimately responsible for the investment decision.

Ownership

(C) Monitoring

For the Secondaries and Primaries activity, along with active dialogue with GPs, an ESG monitoring questionnaire was developed in 2010 in order to raise awareness of ESG and evaluate their progress over time. This questionnaire is sent to Ardian's GPs on an annual basis in order to address both primary and secondary transactions. The questionnaire aims at assessing GPs practices and progress at both investment process and management company level.

Collected data allows to follow up on progress for each individual fund, and the ESG performance data is then stored in Ardian's database. This information also allows Ardian to establish an ESG benchmark for GPs using a proprietary scoring methodology. The ultimate goal is to encourage GPs to incentivize ESG integration by portfolio companies.

Ardian has implemented a tailored debriefing system for its GPs. For each participating GP, Ardian develops an individual ESG scorecard that highlights GP ESG score, its best practices and areas for improvement. Ardian sends GPs their individual scorecard and can arrange a debriefing call on request. This represents the opportunity for an open and qualitative discussion on the evolution of the GPs ESG performance, its good practices and areas for improvement.

Another lever for Ardian to monitor ESG issues during the holding period is the fact that Ardian often secures a seat on the Boards of funds in which it invests.

In 2022, Ardian has continued monitoring GP's ESG performance thanks to the monitoring questionnaire that it had developed in 2010. It aims at assessing GPs' practices and progress at both the investment process and the management company level. Ardian develops an ESG score for each participating GPs based on their responses to the questionnaire and using a proprietary scoring methodology. Ardian also develops an individual ESG scorecard that highlights a GP score, its best practices and areas for improvement. This document is shared with participating GPs. During the reporting year, the Sustainability team has held many debriefing sessions with GPs – showing them the ESG scorecard that was established based on their answers to the monitoring questionnaire – as opportunities for open and qualitative discussions on the evolution of the GPs' ESG performance, its good practices and areas for improvement. Overall, in 2022, Ardian has monitored the ESG performance of more than 205 GPs.

Ardian Real Sustain Tool: In order to assess the ESG performance of assets and funds, Ardian developed a proprietary tool in 2015 with the support of external experts called "Ardian Real Sustain Framework". This framework allows Ardian to make sure that priorities such as green certification, energy efficiency, and tenant satisfaction are correctly implemented to ensure profitability of investments in the long term. Moreover, the investment team with the support of the Sustainability team uses this tool at all phases of the investment process. It provides concrete guidance on how to apply the ESG integration policy we have developed. The framework collects key performance indicators with regards to building design, technical characteristics and initiatives which allow us to ensure that the following environmental, social and governance risks are monitored.

(B) Process two

Systematic CRREM assessments for the portfolio

For its Real Estate activity, Ardian has initiated a two-stage process to identify, measure and reduce GHG emissions of assets:

1. Measuring emissions and carbon trajectory: AREEF II monitors the assets' carbon emissions targets based on the work of the Carbon Risk Real Estate Monitor (CRREM), an EU-funded program fostering the decarbonisation of the building sector which has become an industry standard.

This tool facilitates the identification of decarbonisation initiatives and associated CAPEX.

2. Taking action: Additionally, the tool allows the development of specific carbon reduction strategies for each Real Estate Property to ensure the long-term alignment of the Real Estate Properties with the Paris Agreement objectives (with associated CAPEX for each measure). The Fund uses the CRREM tool in order to develop carbon reduction trajectories for its Real Estate Properties, according to their countries and property categories.

The investment team maintains a constant dialogue with the portfolio company's management teams and actively monitors the evolution of their ESG practices. The results of these ESG reviews serve as a basis for the establishment of recommendations and goals with concrete action plans to help portfolio companies to improve their ESG performance. Ardian believes that sustainability monitoring of assets should be individualized and rooted in materiality. Therefore, we use a tailored and adapted list of sustainability criteria depending on the material issues identified, in addition to the common set of KPIs.

ESG issues are considered throughout the value chain and depend on key characteristics such as size of the asset, sector, operational specifics, or geographic location.

With regards to environmental criteria, Ardian teams' focus areas may include a company's environmental policy and environmental management system, energy consumption and greenhouse gas emissions, water consumption, and waste generation.

With regards to social criteria, Ardian teams' focus areas may include human resources management, diversity and equal opportunities, and health and safety policy. Whenever possible, Ardian encourages profit-sharing and other value sharing schemes with employees.

With regards to governance criteria, Ardian teams' focus areas may include the creation of dual structures in the form of an executive board and a supervisory board, on which external qualified members sit, where they do not exist; the creation of remuneration and audit committees to boost transparency; sustainability strategy; risk management; and business ethics.

During the holding period, the Sustainability team conducts an annual review of portfolio companies' ESG performance in coordination with the Investment team.

This annual review, also known as the Sustainability engagement campaign, has been a long-standing feature within Ardian's portfolio. The Sustainability engagement campaign supports Ardian's ESG data collection efforts and dialogue with the portfolio's companies. It includes among its outcomes individualized action plans intended to help companies improve their performance on identified priority areas. The action plans are updated on an annual basis to support alignment with portfolio companies' global strategy.

Ardian investment teams are also in regular contact with portfolio companies' management, which can assist in continued monitoring and engagement on ESG performance.

Since 2019, our assessment of Sustainability engagement campaign data has included the use of a proprietary sustainability measurement methodology that seeks to assess the impact of investments on their ecosystem and measure companies' contribution to society and the environment across their value chain. It is based on internationally recognized frameworks: the Impact Management Project framework, the Theory of Change and UN Sustainable Development Goals (SDGs).

In complement with action plans, Ardian monitors a set of common KPIs, in line with Ardian Sustainability priorities, the ESG Data Convergence Initiative (EDCI), and SFDR Principal Adverse Impact (PAI) indicators.

In addition to the support that is provided as part of the Sustainability engagement campaign, portfolio companies are also invited to participate in Ardian Circle. Ardian Circle is a community of executives from the Ardian portfolio that allows cross-fertilization, knowledge sharing and collective intelligence on a wide variety of sustainability topics.
